The act of continuing to use the services after the publication or communication of a note regarding any modification of this policy will be understood as a consent to the changes.

1. Responsibility and competence

OrthovetPlus is responsible for personal data under its control. We have established procedures to effectively safeguard all the personal information we collect. We are committed to maintaining the accuracy, confidentiality and security of your personal information, and we will ensure that you have access to information on the procedures we use to manage your personal information. You can ask questions and concerns regarding these procedures at OrthovetPlus via the email address info@orthovetplus.it. Each report will be examined and we will take appropriate measures. We will cooperate with the competent authorities to resolve any dispute that can not be resolved between us and the individual user.

2. Consent

By using the Services, you sign your consent to the terms and conditions of this policy and to our collection, use and release of your personal information as described herein. You can either withdraw or change your consent to the collection, use or disclosure of information at any time by contacting OrthovetPlus at info@orthovetplus.it. In some circumstances a change to the signing of consent may alter your ability to use the services.

3. Collection of information

We will keep the information only for the period necessary for its use in these terms. Information that will no longer be necessary will be destroyed, deleted or made anonymous, although copies of this information may continue to exist as a backup. We collect your e-mail address directly with the purpose of sending you marketing emails, from which you can unsubscribe at any time. These emails may contain trackers, to verify the opening of the emails themselves or any links present, with the aim of improving the quality of our services.

We also collect information about your computer that does not allow us to identify you while browsing the website www.orthovetplus.it, such as an IP address, time of access, browser, resolution, etc. We may use cookies to track the computer in use through separate sessions. We collect this information for statistical purposes, and we will not attempt to reconnect it to specific users. However, we may view the logs of our server for the purpose of identifying unauthorized access attempts, and if these could represent criminal behavior we could provide these data to law enforcement to investigate. The use of the OrthovetPlus application is subject to an additional policy which must be expressly approved during registration within the application itself, with respect to which this policy is independent.

4. Transfer to third parties

We may transfer your personal information under the request of government agencies, law enforcement or regulatory agencies, or to meet regulatory requirements. We may transfer your information to partners to whom we are contracting services, such as sending newsletters, ensuring in this case that such partners do not use such information for purposes other than providing the agreed service. We may eventually cede your information in the event that all or part of our business is transferred.

5. Accuracy and access

OrthovetPlus is responsible for ensuring that all personal information contained in our records or released to third parties for the purposes described above is complete and up to date. A written request is required to access your personal information. You will be informed about the personal information we hold about you, and we will be aware of the use that has been made of this information, as well as identifying each of the third parties to whom the the information has been released. You will have access to your information and if you prove that they are inaccurate or incomplete they will be duly modified or integrated. You should promptly notify us if you find inaccuracy in our data, if your personal information changes or if you want to remove your information from our files. 6. Transfer and storage

You should be aware and consent that your personal information may be transmitted, transferred, processed outside Italy, and wherever it may be required by a government authority under legal orders and laws applicable in these jurisdictions. 8. Minors

Minors (persons under the age of majority in your jurisdiction) are not eligible to use the services without supervision, and we request that minors not send us any personal information. If you are considered a minor in your jurisdiction you may only use the services in conjunction with or under the supervision of an adult. OrthovetPlus does not knowingly collect personal information from minors.
